Approval of Minutes:

OLD BUSINESS

Chair Pillon stated that the zoning resolution book needed to have final review and completion. Chair Pillon stated that the previous hearings were evidence that without a B1 and B2 zoning districts, and reviewing the PUD, it is proving difficult for businesses to come into our community for growth. Chair Pillon said that since the zoning resolution change of removing the B1 and B2 in 2010, the PUD hearing previously heard is the first that has come before the Zoning Commission. Chair Pillon discussed whether the ZC could come up with a temporary approval of a PUD, business and residential. Discussion was that the Jim Cotugno, applicant from previous hearing did not submit the proper application to the Zoning Commission for approval. The ZC informed Mr. Cotugno that they could not submit his request to the Trustees because it was not complete and it would be sent back to the ZC without approval.

Chair Pillon said that he would like to review Section 2 of 2 of the zoning resolution book. Also, to review the signage portion and complete it.

Zoning Inspector Mike Berry informed the Zoning Commission that Holly from Regional Planning would be in attendance at the next meeting to discuss the overlay districts.
