Purpose of Special Meeting:

1. Junk Motor Vehicle JMV24-01

a) Determination of JMV

Trustee Horn made a motion to approve Resolution #25-2024 - Remove Junk Motor Vehicle at 3280 Shepard Avenue, seconded by Trustee Leith. The motion passed with 3 yes votes.

b) Agreement with A&L Towing and Recovery

Trustee Horn made a motion to enter in to a contract with A & L Towing and Recovery for 1 year period to remove any illegally parked vehicles determined by the Township. The Township will pay no fees. The vehicle owner will be responsible for all fees. Seconded by Trustee Leith. The motion passed with 3 yes votes.

2. Lakeside Stormwater Improvement Project Phase 1-4

- a) Resolution 22-2024 to enter into Modification No. 1 with MS Consultants Inc. MS Consultants Inc. Agreements Modification No. 1 to Agreement for final engineering services of 03/21/2022 and Grant Administration Agreement.
