Also showed that if the Safety Grant is approved and we are awarded 3 more full-time employees, the grant will pay for 3 years. We will need a new levy to continue to pay them in year 4.

Discussed overall spending for the 2191 fund, Fire Department has reached more than 1.8 million for year 2021. Fiscal Officer has reviewed all expenses and feels all were appropriate charges for Fire Department operations. Reaching the maximum of Amended Certificate for collected revenue will need to be watched closely.

A motion was made by Bill Yates to approve Resolution 25-2021 to increase fund 2191 appropriations to payoff current fire loans. Second by Doug Leith, Rollcall all Yes.
