<u>Comments from the floor:</u> Mark Sherby 3280 Lakeside Road discussed the presented petition regarding Zoning Application #21-38 as well as concerns of the residents for other properties that may come up for consideration to be rezoned.	
Robin Thompson 3295 Lakeside Road, Millersport, Ohio asked about the \$524,000.00 from the American Rescue Plan. She said that at the last meeting, it was mentioned that this money would be directed toward Fairfield Beach. She asked why some of that money could be split with Lakeside and Fairfield Beach. Trustee Horn said that studies need to be made regarding the Route 360, Hollywood, Lakeside Road, etc.	
Trustee Horn spoke to Tom Bradford from ODOT and he said they had identified a 15" tile under Route 360 at Seller's Drive that was blocked and wouold be replaced. Tim Morris said that he felt ODOT had been listening to the issues that were affecting the residents. John Kochis has reviewed the possibility of applying for a FEMA FMA grant as has determined that it would have zero chance of being approved based on previous successful grant recipients.	

No name creek is being utilized by Buckeye Lake Village as an outlet for their storm water system. Since Walnut Township will want to access this waterway for any future storm water projects we need to coordinate with the Village to ensure the grades of No Name Creek are set properly to accept flow from Walnut Township. Trustee Horn also addressed a possible Zoning overlay district to prohibit future fill within the floodplain. Alan Turnbull 4495 Canal Road, Pleasantville addressed the Trustees regarding property at 4615 Canal Road Pleasantville, Ohio. Mr. Turnbull stated he had a petition signed by neighboring residents supporting the demolition of the house on his property. Trustee Horn stated he ordered a title search to identify any property owners and an ad will be placed in the newspaper for notification. He wants to start the process using the Land Bank for the demolition. He stated that the Land Bank allows each township one demolition project at no cost to the Township and once the Land Bank recovers the cost through property taxes another project can be applied for. Mr. Turnbull also mentioned that 8900 Lake Road has at least 4 cars in the back yard that have been there for years. Trustee Horn stated that we will place that on the property maintenance list.
