The Hearing was called to order at 7:01 PM by Zoning Commission Chair Pillon and the Pledge of Allegiance to the Flag was recited.

#### **Advertised Purpose of Hearing:**

The purpose of the Hearing was for consideration of a zoning district change application submitted by the Walnut Township Trustees. The property proposed to be rezoned is located behind 11420 Millersport Rd. (Parcel #0460005970). The Walnut Township Trustees are requesting a rezoning district change from RR (Rural Residential) to I-2 (General Industrial District) for 2.01 acres from the 6.28 acre parcel.

**Discussion:** Chair Charles Pillon stated that Regional Planning Commission made a recommendation for the rezone stating that they typically do not support a split, but would do so in this case.

Mr. Horn proposed that the rezone be a Permitted Use in I-2.

Dick Williams asked Mr. Horn what is distributed on the roads in the winter? Is it salt? It is salt mixed with grit, 50-50. Mr. Horn stated that he represented the Trustees who sent him to request a rezone to an I-2, but he is requesting the commission to consider granting an I-1 zoning district change.

Motion made by Charles Pillon the recommendation that the rezone district change be modified to I-1 but would accept an I-2 as a permitted use, Ben Patterson offered a second,
