Motion was made Charles Pillon to revise Section 10.7 (1) (b) to add at the beginning of paragraph (b) "the parking of" and add to the end of the paragraph 10.7 (1) (b) "lots under 10,000 square feet", second by Daria Arbogast,

Motion by Daria Arbogast to remove 11.22(c) (g) from Article XI- Conditional Use Regulations, there was no second offered.
